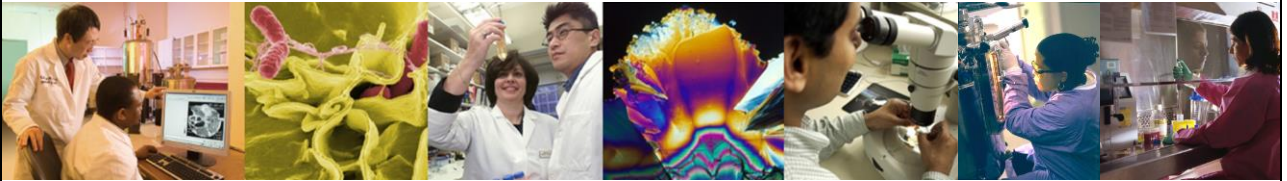

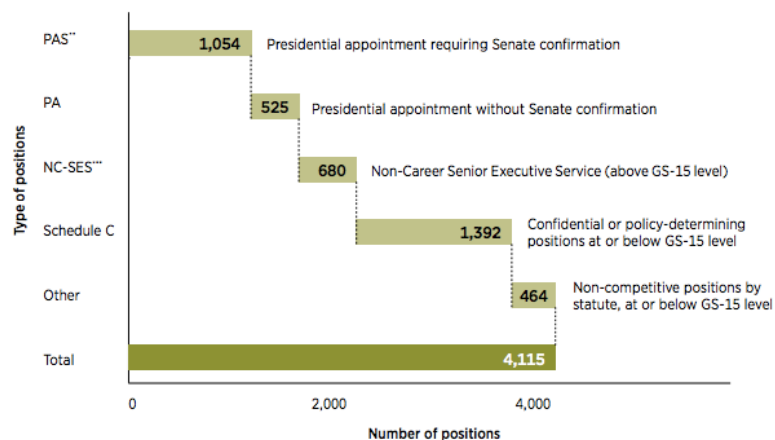

A new administration typically makes ~4,000 appointments. Over 1,000 require Senate confirmation.

Status: 2016 Presidential Transition

Pre-Election

- **May 2016** – Transition Council Established and Agency Transition Leads Designated
- **Aug/Sept 2016** – Acting Officers Designated
- **Oct 28, 2016** – Agency Briefing Materials Submitted Electronically

Post-Election

- **Nov 2016** – President-Elect and VP-Elect Offered Support
- **Nov 2016** – Agency Review Teams Arrive
- **Nov 2016** – Selection of Incoming Presidential Appointees Begins

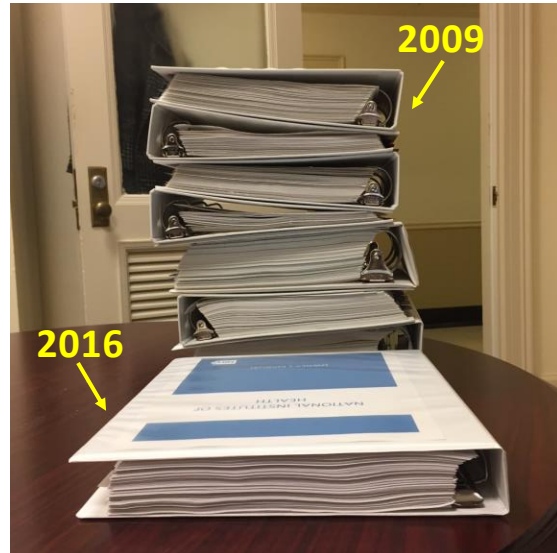
Post-Inauguration

- **Jan 2017** – Inauguration and Onboarding of New Political Appointees Begins

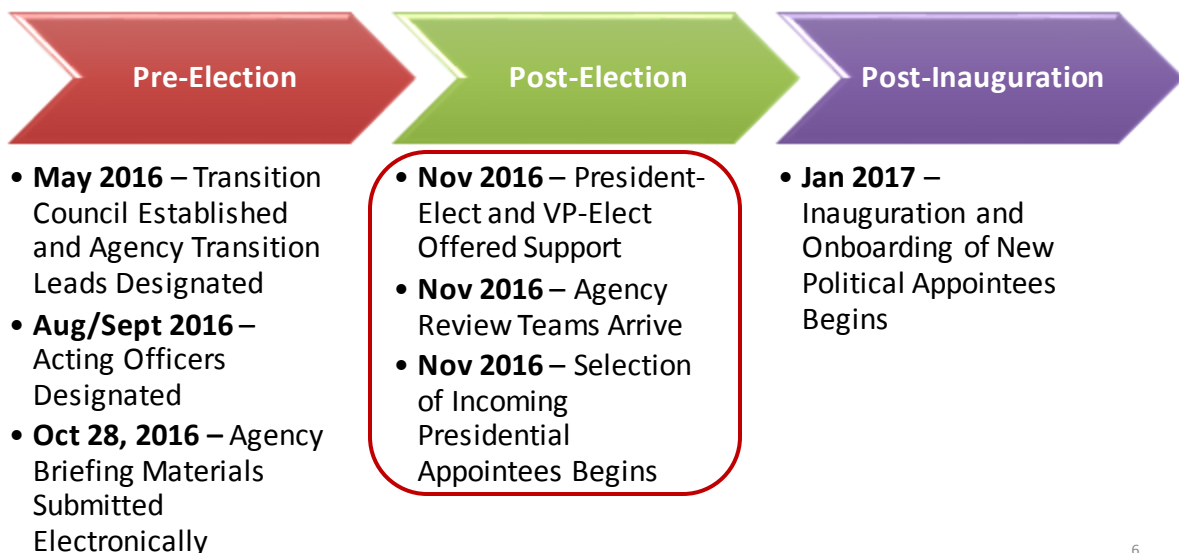

Leadership (nominated)

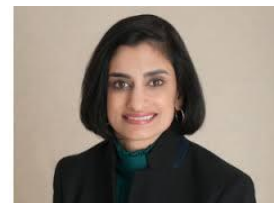
▪ HHS – Rep. Tom Price

- Chairman of Committee on the Budget and a member of both the Congressional Healthcare Caucus and the Doctors Caucus
- In 2014, Dr. Price met with Dr. Collins and stressed:
 - The importance of scientific discoveries, and
 - The economic benefits of empirical research



▪ CMS – Ms. Seema Verma

- President and Founder of SVC, a health policy consulting company
- Worked with Gov. Mike Pence to design Indiana's Medicaid expansion plan (Healthy Indiana Plan 2.0)

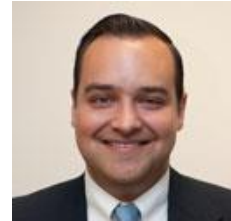

- Trained as an RN, with a Masters in Counseling and Administration



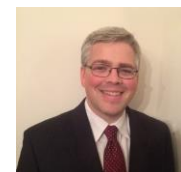
▪ Ms. Marie Meszaros
