Congressional Leadership Updates

- Election for House Speaker contentious first week of the 118th Congress set the stage for another historic moment for the Speakership in October.
- Change in the House Speaker
 - On October 3, 2023, then Speaker
 McCarthy was voted out of his position.
 - The first time in history the House has removed its leader.
 - On October 25, 2023, Congressman Mike Johnson (LA-04) was elected as Speaker of the House.

Senate Confirmation Process

- HELP Committee hearing on October 18, 2023, and vote on October 25, 2023.
 - Final Vote 15-6
 - Highlighted topics included prescription drug pricing and improving clinical trials.
- Full Senate Vote on November 7, 2023.
 - Final Vote 62-36
- On November 9, 2023, Dr. Bertagnolli took the helm as NIH Director, the second woman to hold the position.

Looking Forward – Upcoming Deadlines

- December 31st Expirations
 - Annual National Defense Reauthorization Act (*moving through Congress this week).
- January 19th Expirations
 - Funding for Agriculture-FDA, Energy and Water, Military Construction-VA, and Transportation-HUD bills.
 - Health programs, including community health centers and pandemic preparedness authorities (including the Special Diabetes Program).
- February 2nd Expirations
 - Funding for Commerce-Justice-Science, Defense, Financial Services, Homeland Security, Interior-Environment, Labor-HHS-Education, Legislative Branch, and State-Foreign Operations bills.

FY 2024 Appropriations

- On June 3, 2023, President Biden signed the Fiscal Responsibility Act.
 - For FY24, caps non-defense discretionary spending at \$703.65 billion.
 - Includes a mandate that if on April 30, 2024, any part of the government is funded by a CR, a mandated cut is applied to all government discretionary funding.
- On November 16, 2023, President Biden signed the second FY24 CR (H.R. 6363) into law.
 - 1. Provides funding for NIH through February 2, 2024.
- Congress must now negotiate a final FY24 package. Possible options include:
 - 1. A year-long CR
 - 2. Omnibus
 - 3. Minibus this could either be multiple minibuses or a combination of minibuses and a CR
- The January 19, 2024, deadline will provide more insight into what might happen with NIH funding.
